# Adult Education Services High School Equivalency Diploma – Career-ready Portfolio Pathway Guidance

#### The Career-ready Portfolio Pathway

The Career-ready Portfolio Pathway will provide individuals enrolled in the Arizona adult education system who have not received a high school diploma, but who accumulate and document 22 points in the Academic and Career Readiness areas, a High School Equivalency (HSE) Diploma. Individuals using the Career-ready Portfolio Pathway are still required to pass the Arizona Civics Test.

By adding the Career-ready Portfolio Pathway, Arizona now has a third pathway to the HSE diploma. The GED\* Test Pathway and the College Credit Pathway are still available as alternatives for individuals seeking to obtain their High School Equivalency Diploma in Arizona.

State-funded WIOA Title II providers in Arizona will be responsible for implementing the Career-ready Portfolio Pathway in Arizona. ADE/Adult Education Services will provide specific guidelines and technical assistance to adult education providers to successfully implement this new pathway.

#### **Eligibility for the Career-ready Portfolio Pathway**

As mandated per A.R.S. § 15-702, individuals who are sixteen years of age or older and not enrolled in school or required to be enrolled in school and lack a high school diploma, will be eligible for the Career-ready Portfolio Pathway.

Additionally, to be eligible to get an HSE Diploma through the Career-ready Portfolio Pathway, candidate must be actively enrolled at one of the Arizona Department of Education (ADE)-funded adult education programs.

Individuals age 16 and 17 shall also be required to provide:

- A signed and notarized statement of consent from a parent or legal guardian, and
- An official withdrawal form from the last school attended verifying that the individual is no longer enrolled.

## Requirements of the Career-ready Portfolio Pathway

The specific requirements of the Career-ready Portfolio Pathway are:

- Applicant must be currently enrolled and in qualified status at the time of the application at one
  of the ADE-funded adult education programs.
- Applicant must accumulate and document 22 points in the following two areas:
  - Academic Readiness (14 points): Student must meet the high school graduation requirements in ELA, Mathematics, Science, and Social Studies.
  - Career Readiness (8 points): Candidate must show employability and workforce preparation through a variety of different sources.
- Pass the Arizona Civics Test.

### **Academic Readiness Area**

The adult education student can accumulate the required 14 points in the Academic Readiness area by combining:

- High school credits
- 100+ level college credits
- Developmental ed. college courses
- GED® subtests passed (2014 Version)
- Adult education class/course completion

Points in the Academic Readiness area are awarded as follows:

#### **Career Readiness Area**

The eligible student may document the required 8 points in the Career Readiness area by earning points from the following sources:

- Credit bearing college courses
- IET or I-BEST course completion
- CTE credits
- Arizona or nationally recognized Career Readiness Credential
- Employment verification
- Internship verification
- Industry Recognized Credential

Points in the Career Readiness area are awarded as follow:

# Applying for an HSE Diploma through the Career-ready Portfolio Pathway

Adults eligible to apply must be a qualified adult education student at a state-funded adult education provider. The adult education program will be required to verify and submit the supporting documentation and application to the Arizona Department of Education on behalf of the eligible student.

A qualified adult education student is a learner who:

- Is currently enrolled in a state-funded adult education program at the time of the application
- Has accumulated a minimum of 12 hours of attendance, and
- Has completed the initial assessment in all required subject areas.

There are no exceptions to these requirements.

#### **Career-ready Portfolio Pathway Application Process**

State-funded adult education programs will be required to sign an assurance during the grant application process in which they agree to facilitate the process for HSE attainment through the Career-ready Portfolio Pathway, in accordance with ADE/AES guidelines. This includes counseling and referral services to eligible students.

Eligible students are required to collect and bring the required documentation to the adult education program. Once student brings the required/supporting documentation to the program, a designated staff member will determine if the supporting documentation qualifies for the Career-ready Portfolio Pathway. Adult education providers must provide guidance to eligible students regarding the documentation they should use to fulfill the requirements of this pathway.

Once all documentation is complete, the designated adult education staff member will submit the required documentation and Career-ready Portfolio Pathway Application to the Arizona Department of Education on behalf of the eligible student.

ADE/AES will have the final decision to determine if all the submitted documentation meets the requirements of this pathway.

Note: Per the Code of Federal Regulations (CFR200), under §200.469 Student Activity Costs, costs incurred for intramural activities, student publications, student clubs, and other student activities, are unallowable, unless specifically provided for in the Federal award.

## **Arizona Civics Test Requirement**

As of January 1, 2017, any person wishing to obtain an Arizona high school equivalency diploma must pass the Arizona Civics Test (per A.R.S. §15-701.01)

Applicants who passed the Arizona Civics Test while enrolled in high school, must request an official transcript in a sealed envelope from the educational institution where the test was passed. This transcript must be turned in as part of their supporting documentation to the adult education program.

If an applicant hasn't passed the Arizona Civics Test, then the student must create a GED.com account to schedule, pay for, and complete the test.

#### Financial Aid Eligibility for the Career-ready Portfolio Pathway

Federal regulations establish that to be eligible to obtain financial aid, candidates must, among other things, "show you're qualified to obtain a college or career school education by: having a high school diploma or a recognized equivalent such as a General Education Development (GED) certificate."

Individuals wanting to earn a High School Equivalency Diploma through the Career-ready Portfolio Pathway may be eligible for financial aid if they are currently enrolled in an eligible career pathway program and meet one of the "ability-to-benefit" alternatives.

For information about these criteria contact the financial aid office at a postsecondary school. The financial aid counselor can help determine if the school offers an eligible career pathway program and about any ability-to-benefit tests the school uses.
