

SAM.gov Registration Update Instructions

IMPORTANT: ADE is not affiliated with <u>SAM.gov</u> and cannot assist with registration questions, nor does ADE have access to automatically update your expiration date.

To maintain federal compliance, ADE must place entities with expired registrations on a global hold in the GME system. A global hold blocks all new funding approvals as well as all reimbursement activity until an updated registration document is received by Grants Management.

- Please ensure that your SAM.gov registration is renewed in a timely manner as the renewal process may take several months. This also applies to name/address changes or other updates to your existing SAM.gov registration. For information on updating your registration visit <u>SAM.gov</u>
- If your organization's registration is <u>current</u> please provide it to ADE Grants Management when it is renewed to avoid being placed on a global hold.
- Each entity is solely responsible for providing ADE Grants Management with documentation to support an active SAM.gov registration.
- ADE cannot provide reminders for expiring/expired registrations.
- ADE cannot update the current expiration date on file without proof of active registration status represented by the submission of an updated SAM.gov Entity Information page printout.

Removing a Global Hold for Inactive SAM.gov Registration

If your organization is placed on hold for any SAM.gov registration renewal or other issue which renders it inactive, the hold can only be removed once ADE receives a copy of your current SAM.gov registration Entity Information page verifying an active registration.

Submit your current/active PDF printout of the of the organization's SAM.gov Entity Information to Grants Management via a service request on ADE's Help Desk support portal.

- Expiration Date has been renewed
- Physical Address and Mailing Address are correct
- Version displayed = "Current Record"
