

Family Education Rights and Privacy Act (FERPA) / Protection of Pupil Rights Amendment (PPRA) Assurances Announcement

What is the FERPA/PPRA Assurance?

Based on a letter dated March 28, 2025, from United States Department of Education's Student Privacy Policy Office (SPPO), the Arizona Department of Education (ADE) is required to collect assurances from all federal grant subrecipients of their compliance with the Family Education Rights and Privacy Act (FERPA) and the Protection of Pupil Rights Amendment (PPRA). In addition, the Arizona Department of Education has been tasked with collecting documentation of our federal grant subrecipient's adherence via their FERPA/PPRA policies & procedures. This information will be collected via your Grants Management Enterprise (GME) LEA Document Library. The assurance and all supporting policy & procedure documentation MUST be submitted by April 30, 2025. Organizations that do not meet this requirement may be placed on hold.
