Ranking school sites for Title I Eligibility – October 1 data requirements

Category: Compliance and Procedure Date: 4/30/2025 Effective: FY26 Elementary and Secondary Education Act (ESEA) Consolidated Grant Cycle

Title I, Part A of the ESEA provides federal dollars to schools to help students at risk of not meeting the Arizona K-12 Academic Standards. Current appropriations may not provide enough money to serve all eligible children; therefore, the law intends to concentrate the funds in schools with the highest percentages of poverty and to provide sufficient funds to make a difference in the academic performance of these students. The table on the next page is designed to assist LEAs in ranking schools to be served with Title I funds based on their selected poverty measure, while following the Arizona Department of Education's guidance on using October 1 data. All data references that are used rely upon the Local Education Agency (LEA) collecting and reporting accurate student-level data for October 1 enrollment counts as required by the Arizona Department of Education. This includes using appropriate methods and forms of collecting data, effective efforts of gathering data for all students with respect to guidance, and the National School Lunch Program (NSLP) or other applicable programs affecting Income Eligibility reporting.

Summary:

The Academic Achievement Unit strives to support our LEAs as they complete their ESEA Consolidated Grant application. It is vital that the Title I School Eligibility page within that application is both accurate and complete using the correct verifiable data sources for October 1. This policy bulletin is both a reminder of applicable statutes and updated to reflect recent non-regulatory guidance from the United States Department of Education (USED) regarding within-district allocations for Title I-A.

**Served in rank order: Providing funds for a site via the PPA process. Sites must receive a PPA of the same amount or more as those ranked below them.

***High School Priority: In 1994, 2001, and 2015, Congress prioritized Title I funding to support high-poverty high schools before serving higher elementary schools to ensure College and Career Readiness

Note: A school site that is no longer eligible for Title I funds but was both eligible and served in the prior year may elect to use the Grandfather Clause to be served one additional year. It must still be ranked according to the method chosen by the LEA.
